iSelect Board Changes

- **Appointment of Non-executive Director, Mr Brodie Arnhold**
- **Departure of Non-executive Director, Mr Greg Camm**

iSelect Limited (ASX: ISU) is pleased to announce the appointment of Mr Brodie Arnhold to the iSelect Board as an independent non-executive director, effective 25 September 2014.

Mr Arnhold is CEO of Melbourne Racing Club and has over 15 years' domestic and international experience in private equity, investment banking and corporate finance.

Prior to Melbourne Racing Club, Mr Arnhold worked for Investec Bank from 2010-2013 where he was responsible for building a high-net-worth private client business. Prior to this, Mr Arnhold worked for Westpac Banking Corporation where he grew the institutional bank's presence in Victoria, South Australia and Western Australia, and from 2006-2010 held the role of Investment Director at Westpac's private equity fund.

Mr Arnhold is a chartered accountant and has worked at leading accounting and investment firms including Deloitte (Australia), Nomura (UK) and Goldman Sachs (Hong Kong).

iSelect Executive Chairman, Damien Waller said: "Brodie is highly respected and his skills and experience will be a valuable addition to the iSelect Board as we embark on our next stage of growth."

The Company also today announced the resignation of Mr Greg Camm as Non-executive Director for personal reasons.

Mr Camm joined the iSelect Board in 2012 and has occupied the position of Non-executive Director and Deputy Chairman since that time.

iSelect Executive Chairman, Damien Waller said: "Greg made a strong contribution to the iSelect Board and we're sad to see him leave. My Board colleagues and I thank him for his work over the past two years and wish him all the best for the future."

As a consequence, Mr Camm will not be standing for re-election at iSelect's 2014 Annual General Meeting. His official date of departure will be 31 October, 2014.
